#### Verification of Finances:

1) This affidavit of support must be signed by the sponsor, and hand stamped or sealed by a notary public, bank official, or individual authorized to certify documents.

2) Each sponsor is also required to provide documentation of their ability to provide financial support. Bank statements that are **no more** than two (2) months old at the time of submission need to show: **credits & debits and should specifically state; the date, sponsor's name, how long they have had the account, and if funds are available for the educational sponsorship for the named student. Or** an original letter on the **banks official letterhead** with a **bank official's signature and seal** from the **financial institution**. The letter needs to verify the current account and an **average 2** month balance of **at least \$11,000.00** U.S. dollars and if the account is and has been in good standing.
